



### **Waiver of Liability and Assumption of Risk**

I acknowledge and understand the contagious nature of the Coronavirus/COVID-19 and that the Centers for Disease Control and Prevention (CDC), Florida Department of Health (FDOC), and other public health authorities continue to recommend social distancing and other health and safety precautions.

I further acknowledge and understand that the Lakewood Ranch Business Alliance does not represent or guarantee in any way that I will not be exposed to the Coronavirus/COVID-19 by attending the event, and I voluntarily consent to and assume the risk of such exposure.

I voluntarily attend events hosted by the Lakewood Ranch Business Alliance and acknowledge and understand that I am increasing my risk of exposure to the Coronavirus/COVID-19. I agree that I will fully comply with all of the rules, requirements, policies, and procedures of the Lakewood Ranch Business Alliance, the venue where the event is located, and any other applicable organization or governmental agency.

### **I hereby represent and attest that as of the time of the event:**

- I am not currently experiencing any symptom of illness nor will I attend event if I am experiencing any symptom of illness at the time of or 24 hours prior to the event (including but not limited to cough, shortness of breath, difficulty breathing, fever, chills, repeated shaking, muscle pain, headache, sore throat, or new loss of taste or smell).
- I have not traveled internationally within the last 14 days.
- I have not traveled to an area in the United States of America that is known to be a high-risk location with respect to the Coronavirus/COVID-19 within the last 14 days.
- To the best of my knowledge, I have not been exposed to any individual with a suspected or confirmed case of the Coronavirus/COVID-19.
- I have not been diagnosed with Coronavirus/COVID-19 and not yet cleared as non-contagious by State of Florida officials.
- I am following all CDC guidelines and FDOH guidelines.

\*I agree to provide my own mask that covers both my mouth and nose, and I agree to wear such mask at all times during the event when social distancing cannot be practiced.

**I (referred to herein as "Attendee") agree as follows:**

1. **WAIVER OF LIABILITY AND RELEASE: ATTENDEE, FOR HIMSELF OR HERSELF, AND FOR ALL OF ATTENDEE'S SUCCESSORS, ASSIGNS, REPRESENTATIVES, HEIRS, BENEFICIARIES, AGENTS, AND AFFILIATES (COLLECTIVELY THE "ATTENDEE PARTIES"), HERBY COMPLETELY AND UNCONDITIONALLY RELEASES, WAIVES, AND DISCHARGES THE LAKEWOOD RANCH BUSINESS ALLIANCE ("LWRBA") AND ALL OF LWRBA'S SUCCESSORS, ASSIGNS, REPRESENTATIVES, HEIRS, BENEFICIARIES, MEMBERS, DIRECTORS, OFFICERS, EMPLOYEES, AGENTS, AND AFFILIATES (COLLECTIVELY THE "LWRBA PARTIES"), FROM ANY AND ALL LIABILITY, CLAIMS, DEMANDS, AND ACTIONS ARISING FROM OR RELATING TO ANY PERSONAL INJURY OR DEATH, PROPERTY DAMAGE, ACCIDENT, ILLNESS, LOSS, OR COST SUSTAINED BY THE ATTENDEE PARTIES IN ANY WAY WHATSOEVER RELATING TO THE EVENT OR ATTENDANCE AT THE EVENT (INCLUDING, WITHOUT LIMITATION, SUCH INJURIES, DAMAGES, ACCIDENTS, ILLNESSES, LOSSES, OR COSTS ARISING FROM OR RELATING TO EXPOSURE TO THE CORONAVIRUS/COVID-19).**
2. **ASSUMPTION OF RISK: ATTENDEE FULLY ACKNOWLEDGES AND UNDERSTANDS THAT ATTENDING THE EVENT COMES WITH SIGNIFICANT RISKS AND HAZARDS (INCLUDING, WITHOUT LIMITATION, RISK OF ILLNESS, PERSONAL INJURY, DEATH, AND PROPERTY DAMAGE). ATTENDEE FULLY ACCEPTS AND VOLUNTARILY AND KNOWINGLY ASSUMES ALL SUCH RISKS AND ASSUMES ALL RESPONSIBILITY FOR ALL INJURIES, DAMAGES, ACCIDENTS, ILLNESSES, LOSSES, AND COSTS SUSTAINED IN ANY WAY WHATSOEVER RELATING TO THE EVENT OR ATTENDANCE AT THE EVENT (INCLUDING, WITHOUT LIMITATION, SUCH INJURIES, DAMAGES, ACCIDENTS, ILLNESSES, LOSSES, OR COSTS ARISING FROM OR RELATING TO EXPOSURE TO CORONAVIRUS/COVID-19**
3. **ACKNOWLEDGMENT: Attendee has fully read the above waiver of liability, release, and assumption of risk, and Attendee fully understands that Attendee is giving up substantial rights by agreeing to such terms and provisions, including right to be present at event if not adhering to all event requirements. Attendee is agreeing to this waiver of liability, release, and assumption of risk freely, voluntarily, and knowingly.**

For ease of reference please find current (as of 7/21/20) FDOH guidelines below:

- Practice social distancing - If you are around other people, keep 6 feet between you when possible. Avoid hugs, handshakes, large gatherings and close quarters.
- Requirement to wear a cloth face cover at event. Cover your mouth and nose with a cloth face cover when around others and while attending event.
  - You could spread COVID-19 to others even if you do not feel sick. The cloth face cover is meant to protect other people in case you are infected.
- Avoid touching eyes, nose and mouth. Hands touch many surfaces and can pick up viruses. Once contaminated, hands can transfer the virus to your eyes, nose or mouth.
- Host Venues to clean and disinfect "high-touch" surfaces as best possible. This includes tables, doorknobs, light switches, countertops, toilets, faucets, and sinks.
  - Food and drink events to require disposable glasses, plates and cutlery.
